Travel Documents

U.S. citizens on homeport cruises (cruises that begin and end at the same U.S. port) will be able to enter or depart the country with a state issued birth certificate with a raised seal and government-issued photo I.D. AAA recommends the use of a passport valid for at least 6 months after travel dates.

Payment

A deposit of \$100 per person will confirm your reservation. Final payment is due to AAA by March 1, 2011.
